(via Zoom) Receive, discuss and, take action as necessary the Initial Assessment regarding whether redistricting is required for City Council member districts considering the new 2020 census data; and, if so, discuss and consider adoption of redistricting criteria to apply to development of new districting plans, and guidelines for public participation in the redistricting process. *(The City Council may go into executive session pursuant to Texas Government Code §551.071 to receive advice from legal counsel regarding the City's redistricting obligations.)*
7. Set Date or Dates for Drawing Sessions to Finalize Redistricting.
8. Consider and take action as necessary: Texas Communities Group will address the council regarding the mitigation of dangerous or neglected properties.
9. Discuss and take action to adopt resolution 21-11-08-a awarding an engineering contract related to the American Rescue Plan
10. Consider and, take action as may be deemed necessary on routine administrative items and, department head reports.
11. Report from EDB Board Chairman regarding pending grants:
12. Consider and, take action as may be deemed necessary regarding a proposed Christmas tree lighting ceremony by local businesses.
13. PUBLIC COMMENTS: *Limit to Three Minutes.* All public comments shall be made in relation to a posted agenda item unless otherwise decided at the discretion of the mayor. **The council will listen but will not respond.**

**PUBLIC COMMENT:** All individuals desiring to make public comments must sign in on the "Public Comments" sign in sheet at least 5 minutes prior to the start of the meeting. As provided by H.B. 2840 The governmental body must allow the public the right to speak on items on the agenda *during the meeting when the agenda item is being considered* by the governmental body. *Id.* § 551.007(b). Comments are limited to 3 minutes. The council will take the comments into consideration and the comments will be recorded as a part of the deliberation regarding the agenda item being discussed but, the council will not respond directly to the comments.

*The City Council reserves the right to adjourn into Executive Session at any time during the course of this meeting to discuss any matters listed on the agenda*, as authorized by the Texas Government Code, including, but not limited to, Sections 551.071 (Consultation with Attorney), 551.072 (Deliberations about Real Property), 551.073 (Deliberations about Gifts and Donations), 551.074 (Personnel Matters), 551.076 (Deliberations about Security Devices), 551.087 (Economic Development), 418.175-183 (Deliberations about Homeland Security Issues) and as authorized by the Texas Tax Code, including, but not limited to, Section 321.3022 (Sales Tax Information).

The City Council reserves the right to change the order of items on the agenda. Agenda items may be taken out of sequence to accommodate persons appearing before the City Council and/or to aid in the effectiveness of the meeting. Should any final action, final decision, or final vote be required in the opinion of the City Council with regard to any matter considered in such closed or executive meeting or session, then such final action, final decision, or final vote shall be at either: a. the open meeting covered by this notice upon the reconvening of this public meeting, or b. at a subsequent public meeting of the City Council upon notice thereof, as the Board shall determine.
