**ELIGIBILITY REQUIREMENTS FOR MUNICIPAL OFFICE.**

Any person desiring to become a candidate for elected office with the City of Seagraves shall have the following qualifications:

- (1) Be a United States citizen;
- (2) Have been a resident of Texas for at least 12 months, as of the deadline for filing for the office;
- (3) **(a) Pertaining to the Office of Mayor:**

Have resided in the city for at least 12 months preceding Election Day;

- (b) Pertaining to the Office of Alderman:**

Have resided in the city for at least 6 months preceding Election Day;

(4) Have a current voter registration certificate;

Be 18 years of age or older upon the commencement of the term to be filled at the election;

(1) Not have been convicted of a felony for which he or she has not been pardoned or otherwise released from the resulting disabilities;

(2) Not have been deemed mentally incompetent by a final judgment of a court; and

(3) Must qualify under the statutes of Election Code Section 141.00; Local Government Code Section 22.008, 22.032 *et seq.* as amended.

#### **DISQUALIFICATION OF CANDIDACY.**

A candidate for elected office with the City of Seagraves shall be disqualified from such candidacy if, at the time of application for the office or at any time prior to being seated for such office, it is determined that such candidate is:

(1) Delinquent in the payment of ad valorem taxes owed the City on personal property or real estate owned by the candidate that is located in the City. Any person who files as a candidate for election to a public office shall be disqualified from participation in the election for which the candidate has filed if such person is delinquent in the payment of any personal property taxes, real property (ad valorem) taxes on real or personal property located in the City.

(2) Delinquent in payment of certain other municipal liabilities due the City. No person shall be certified as a candidate for a municipal office, nor shall such person's name appear on the ballot as a candidate for such office, nor shall such person be seated for office who shall be in arrears for any unpaid utility services or citation for violation of any municipal ordinance or traffic fine due the City on the last day to file a declaration of candidacy for the office.

(3) Such disqualification shall not apply to unpaid taxes or other municipal liability if, on the day the person files a declaration of candidacy for the office, he or she has filed a valid contest alleging that such taxes are not due or such liability does not exist and is thereafter either declared by final order of a court or other office with applicable jurisdiction to not owe such taxes or liability or, if found to be liable for the same, promptly pays and acquits such liability prior to the election or the canvass at which the results of such election is accomplished.
