

Statements required in notice if the proposed tax rate does not exceed the lower of the no-new-revenue tax rate or the voter-approval tax rate, as prescribed by Tax Code §26.061.

NOTICE OF MEETING TO VOTE ON TAX RATE

A tax rate of \$1.175431 per \$100 valuation has been proposed by the governing body of SEAGRAVES-CITY.

PROPOSED TAX RATE: \$1.175431 per \$100

NO-NEW-REVENUE TAX RATE: \$0.869846 per \$100

VOTER-APPROVAL TAX RATE: \$1.046580 per \$100

VOTER-APPROVAL WITH UNUSED INCREMENT RATE: 1.176431 per \$100

The no-new-revenue tax rate is the tax rate for the 2023 tax year that will raise the same amount of property tax revenue for SEAGRAVES-CITY from the same properties in both the 2022 tax year and the 2023 tax year.

The voter-approval rate is the highest tax rate that SEAGRAVES-CITY may adopt without holding an election to seek voter approval of the rate.

The proposed tax rate is not greater than the no-new-revenue tax rate. This means that SEAGRAVES-CITY is proposing to increase property taxes for the 2023 tax year.

A PUBLIC MEETING TO VOTE ON THE PROPOSED TAX RATE WILL BE HELD ON 09/25/23 at 06:30 PM (CT) at Seagraves City Hall, 309 Hill St, Seagraves, TX.

The proposed tax rate is also not greater than the voter-approval tax rate. As a result, SEAGRAVES-CITY is not required to hold an election to seek voter approval of the rate. However, you may express your support for or opposition to the proposed tax rate by contacting the members of the City of Seagraves of SEAGRAVES-CITY at their offices or by attending the public meeting mentioned above.

YOUR TAXES OWED UNDER ANY OF THE TAX RATES MENTIONED ABOVE CAN BE CALCULATED AS FOLLOWS:

$$\text{Property tax amount} = (\text{tax rate}) \times (\text{taxable value of your property}) / 100$$

The 86th Texas Legislature modified the manner in which the voter-approval tax rate is calculated to limit the rate of growth of property taxes in the state.

The following table compares the taxes imposed on the average residence homestead by SEAGRAVES-CITY last year to the taxes proposed to be imposed on the average residence homestead by SEAGRAVES-CITY this year.
