NOTICE OF MEETING TO VOTE ON TAX RATE

A tax rate of \$1.255911 per \$100 valuation has been proposed by the governing body of SEAGRAVES-CITY.

PROPOSED TAX RATE: \$1.255911 per \$100
 NO-NEW-REVENUE TAX RATE: \$1.255911 per \$100
 VOTER-APPROVAL TAX RATE: \$1.272781 per \$100

The no-new-revenue tax rate is the tax rate for the 2025 tax year that will raise the same amount of property tax revenue for SEAGRAVES-CITY from the same properties in both the 2024 tax year and the 2025 tax year.

The voter-approval rate is the highest tax rate that SEAGRAVES-CITY may adopt without holding an election to seek voter approval of the rate.

The proposed tax rate is not greater than the no-new-revenue tax rate. This means that SEAGRAVES-CITY is not proposing to increase property taxes for the 2025 tax year.

A PUBLIC MEETING TO VOTE ON THE PROPOSED TAX RATE WILL BE HELD ON 09/08/2025 05:30 PM (CT) at Seagraves City Hall, 205 Connors Ave, Seagraves, TX.

The proposed tax rate is also not greater than the voter-approval tax rate. As a result, SEAGRAVES-CITY is not required to hold an election to seek voter approval of the rate. However, you may express your support for or opposition to the proposed tax rate by contacting the members of the Seagraves City Council of SEAGRAVES-CITY at their offices or by attending the public meeting mentioned above.

The following table compares the taxes imposed on the average residence homestead by SEAGRAVES-CITY last year to the taxes proposed to be imposed on the average residence homestead by SEAGRAVES-CITY this year.
