Public Funds Investment Report. Above is the state of our portfolio as of 10-31-19 The Investment account at First United underperformed again this month. The Treasury Bill Rate is 1.66%. This is the rate that is paid on balances over \$500,000.00 at First United Bank. TexPool's daily rate is 2.07% as of 10-31-19 The difference in yield is significant. The Federal Reserve cut interest rates on Wednesday for the third time this year, reversing nearly all of 2018's rate increases. The Fed has now reduced its policy rate by a cumulative 0.75 percentage point this year, just as it did during two mid-business-cycle interest rate adjustments in the 1990s. While those insurance cut cycles were eventually reversed — the Fed returned to interest rate increases — Mr. Powell (Fed Chairman) indicated that increases were not on the table unless inflation showed signs of moving higher. Price gains have been falling short of the Fed's 2 percent target for years, making that unlikely.

I have opened an account with TexPool and moved \$200,000.00 of General Funds to that institution to take advantage of the higher yield. The fund offers the most attractive rates available to public sector investments while assuring the city the liquidity needed to react to sudden changes in cash flow. The only comparable instruments available are Certificates of Deposit at fixed terms of three or more years. Such instruments will offer no liquidity what so ever and are not a reasonable investment at this time. Considering the economic outlook and substantiated trends, I recommend that the investment account be transferred to TexPool as well. The fund is designed to provide municipalities with a relatively high return while offering the flexibility needed to respond to sudden cash flow needs. If the funds are deposited to the TexPool account, the income difference would be \$5,600.00.

Davis-Ray will be at City Hall on the 18th of November to begin the annual audit.

The Rate Study and recommendations for adjusting the sewer rates in anticipation of bond payments will be available for review sometime near Thanksgiving according to Communities Unlimited. As part of the process and to satisfy requirements in the application, it will be necessary to make some budget adjustments to the 2019/2020 budget. The city must separate expenditures in fund 20. Waste Water must be accounted for separately from other Public Works expenses. It will not involve increasing the budget. It will involve reallocating what has already been adopted for Public Works. Renee has worked

up the figures and accounts. (It is attached to this report). I will be discussing this with Derek to be sure it is done properly but when ready it will require a resolution to enact it.

This evening you will be addressed by Ms.Connie Lamm of the Heritage Project of Gaines County and Mr. Bhardwad Subhash PharmD. Who will explain his desire to open a Pharmacy in Seagraves. The New Animal Control Officer, Ms. Lee Rodrigues will introduce herself to you and go over her experience and discuss improving animal control in Seagraves.

The following is from a Legislative Update by TML:

CITIES NOT OUT OF THE WOODS, NOT EVEN CLOSE

On Tuesday, October 22nd Texas House Speaker Dennis Bonnen – who was recorded saying he was determined to see cities have terrible 2019 and 2021 legislative sessions – announced his retirement. But city and county officials should not assume that all is now well at the Capitol.

A key committee chairman, Rep. Dustin Burrows (R-Lubbock), said on the recording that "we hate cities and counties." He also revealed his plan for the state to steal cities' two pennies of local sales taxes to lower school property taxes. This brazen plan to raid city revenues must be strenuously resisted.

Many House members have yet to weigh in on the abusive comments revealed last week. How do those members feel about the notion that mayors are "dumbasses" (the Speaker's actual words) who don't even deserve to be heard when they travel to Austin? Legislators must be called upon to clearly declare where they stand going into 2020 elections and the 2021 session.

For cities with questions about whether their state representative stands with them or against them, there's one easy way they can find out—they can pick up the phone and ask. City officials deserve an answer, one way or the other. If local officials are not satisfied with the responses they get from their representative and senator, the upcoming election is the best means for holding legislators accountable.

This week's good news was due in no small part to mayors and councilmembers who've become fed up with wanton city bashing by some state leaders. It is time to turn that outrage into action and forge a new era of mutual respect and cooperation between local and state elected leaders.
